If you make a mistake or change your mind, exchange your ballot for a new one.</div> <div>VOTE IN ALL COLUMNS</div>		<div>BALLOT ISSUES</div> <div>PROPOSITION ELEMENTARY GENERAL FUND</div> <div>Shall the trustees be authorized to impose an increase in local taxes to support the General Fund in the amount of one million three hundred forty-nine thousand forty-seven dollars and sixty-seven cents (\$1,349,047.67), which is approximately 9.84 mills for the purpose of the operation and maintenance of the educational programs for the school year 2018-2019. Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$13.28 and on a home with a market value of \$200,000 by approximately \$26.57. The durational limit of the levy is permanent once approved by the voters, assuming the district levies that amount each year thereafter.
