RALLY FOR THE MONTANA CONSTITUTION: For more than half a century, Montana's Constitution has faithfully protected our freedoms, rights, and people; it secures what makes Montana special.

But a handful of lawmakers have already proposed 54 constitutional amendments this legislature. That's almost twice as many amendments as our Constitution has seen in its entire history – and this is only the third week of the legislature! These proposals include rolling back our right to a clean and healthful environment and attacks on our courts, privacy and democracy, among other things.

We have a plan and a path to successfully defend our Constitution. But we can't succeed if we're not vocal – we need to let our legislators know that Montanans love and celebrate our Constitution and encourage them to do the right thing. Come rally with us!

Great Falls Rising will be going. We'll meet in the Paris Gibson Square parking lot at 9:30 am on Wednesday, February 1st to carpool. We'll return to Great

Falls shortly after the rally. We hope to have a large representation from our Great Falls constitution supporters.

WHAT IS TRENDING AT THE MONTANA LEGISLATURE: Great Falls Senators leading the charge to bring back smoking in public. SB 205 has been introduced by:

Senator Jeremy Trebas from Great Falls Senator Daniel Emrich from Great Falls Representative Daniel Zolnikov from Billings Representative Mike Hopkins from Missoula Senator Chris Friedel from Billings

This bill will dismantle our Clean Indoor Air Act (CIAA). It will provide businesses the freedom to opt out of the CIAA. Doing so will expose customers entering these businesses to secondhand smoke. There is no safe level of exposure to secondhand smoke; even brief exposure can cause serious health problems and be deadly (CDC). It will put employees at risk for secondhand smoke exposure.

The bill would allow minors into establishments at times when smoking isn't allowed in them. But this would expose kids to thirdhand smoke. People are exposed to the chemicals in thirdhand smoke when they touch contaminated surfaces or breathe in the gases that thirdhand smoke may release (Mayo Clinic). It undermines the CIAA protections Montanans have had for more than a decade and forces workers to make a choice between their own health or a paycheck in a time when cost of living expenses in many Montana communities are high.

It burdens county health departments with licensing smoking establishments, creating a new bureaucracy and contrary to what health departments are charged to do---protect health level.

There is no safe level of tobacco smoke exposure. Completely eliminating smoking is the only way to fully protect people who do not smoke from secondhand smoke exposure (CDC). It would allow businesses to allow marijuana smoking.

Contact ALL of our elected officials in Helena NOW. The hearing for this bill is **Thursday**, **February 2nd**. It's crunch time!

WINTER TRAIL DAYS: Get Fit Great Falls' Winter Trails Day is coming up on Saturday, February 4th. Many of you have participated in the past and, besides being instructional, it's a lot of fun. It's a time to snowshoe and xc ski at Silver Crest, best trails in MT. You MUST register for either or both. Bighorn will be there to lend xc ski equipment (which you need to sign up for at their store in Great Falls), and the snowshoes are available in great quantity. It's a family affair and hot beverages and cookies will be awaiting your arrival.

HOUSED GREAT FALLS: Housed Great Falls (HGF) is a grassroots 501(c)(3) nonprofit that aims to provide missing scaffolding in Great Falls to unhoused and unsheltered community members. Their long term goal is a transitional housing community, with the Cold Weather Drop In Center as an immediate response to a need in our community.

The Cold Weather Drop In Center is a safe, evening space for people who are experiencing homelessness or are stranded during the cold winter months. When temperatures are forecast to be a 'feels like' 25 or lower, the center will be open between 5:00 and 9:30 PM. Overnight service at the Rescue Mission opens at 10:00 PM. The Drop In is being hosted by the First United Methodist Church (FUMC) and is being organized by volunteers from Housed Great Falls (HGF) and relies on volunteers from the community to open. The main meal is provided by volunteers, with additional snacks and beverages provided by HGF and FUMC. They only open if they have a minimum of three volunteers to maintain a

safe environment, so volunteers are never working alone. A volunteer familiar with the Drop-In or a member of HGF can orient you to the responsibilities of helping for a night (or partial shifts; the first or second half of the evening if that is all you are able to do).



GREAT FALLS HISTORY MUSEUM: A Day at the Ozark with Historian Ken Robinson.

There's just something about the Ozark Club! At a time in the 1940s and 50s when Jim Crow discrimination held an iron grip on Great Falls and throughout Montana, Leo Lamar and his unique Ozark Club broke racial barriers. Leo saw an opening in World War II Great Falls, and the door to the Ozark opened to interracial patrons. "Everyone was Welcome" at the Ozark Club. Whites and blacks, young and old, rich and poor, climbed the narrow, dark stairs to the upper floor of the Ozark. LaMar's strategy for success rested on an exceptional entertainment package anchored by a remarkable house band, the Ozark Boys.

The Ozark Club story had faded over the fifty years before Phil Aaberg, Chris Morris, and Ken Robison brought a series of exciting Nights at the Ozark to The History Museum. From 2007 to 2009, a series of seven exciting Nights at the Ozark with prominent national Black Jazz Bands lit up Montana's cold nights. The crowd brought their vibrant memories with them—and the O'Club sprang back to life.

Now it's been another fifteen years, and before memories faded once more, Ken Robison and The History Museum will bring the Ozark back. Join us Second **Saturday**, **February 11th**, 1:00 pm at The History Museum, listen to some of the original jazz and fascinating stories from the O-Club; bring and share your memories of the original Ozark or the Nights at the Ozark Club.
