**GENERAL ELECTION:** Mail ballots were sent out on **October 14th**, and the general election takes place on **November 8th** at the Exhibition Hall at Montana Expo Park. Check to make sure you are properly registered here: My Voter Page - Montana Secretary of State (mt.gov). You can also view if your ballot has been received and accepted.

The Cascade County Election Office will move to Exhibition Hall at Montana Expo Park on Monday, **October 31st** through election day on **November 8th**. If you would like to receive your ballot during this time period, you will need to come over to the fairgrounds. Their office will be closed over the weekend, **November 5rd & November 6th.**

**HARVEST HOWL:** The Rotary Club of Great Falls is once again sponsoring Harvest Howl, an event to support Camp Rotary in Monarch offering programs for youths and veterans. **SCHOOL ACCREDITATION STANDARDS:** Significant changes are being discussed at the Board of Public Education surrounding Chapter 55, which has to do with accreditation standards surrounding libraries, school counselors and class size regulation in our schools. **Public comment ends on November 4th**.

Here are the main things you should know about what is happening:

- 1. Ask the Board to NOT take the Superintendent's recommendation to create a new level of accreditation called "Accredited with distinction." By definition, via Montana Courts and Legislature, accreditation standards are *minimum* standards of quality and there is no stated research or compelling argument to change them into something else.
- 2. DO NOT accept the superintendent's recommendation to remove the staffing ratios for library media specialists in the name of "local control". 10:55:709 The zip code of our children should not determine the kind and quality of access they have to the many, varied and necessary services school libraries provide.

- 3. DO NOT accept the superintendent's recommendation to remove the staffing ratios for school counselors in the name of "local control". 10:55:710 As noted in expert testimony at every phase of this process, school counselors are specifically trained and are indispensable in supporting the "well-being" of each child. It is ironic that the word "well-being" is mentioned eight times in new language in the same document that seeks to eliminate the people specifically trained to enhance it. Please don't eliminate it.
- **4.** Please DO ACCEPT the proposed changes 10:55:712 (5) with one small addition for Class Size: The school district must provide additional and competent human resources when exceeding maximum class sizes.

Please consider submitting written comments to the Board of Public Ed to share your thoughts about the proposed changes. Share your thoughts on social media. Ask friends to submit comments. Personal stories, concerns for children's and grandchildren's education, thoughts from retired teachers are so valuable in these meetings! \*Written public comment can be sent to <a href="mailto:bpe@mt.gov">bpe@mt.gov</a>. through November 4th.
